Additional Details relating to the Baseline Emissions calculations.		
A professional carbon accountancy organisation was used to help create our baseline. The calculation uses the 2025 emission factors developed by the Department for Environment, Food and Rural Affairs (DEFRA) and the Department for Business, Environment & Industrial Strategy (BEIS) for reporting emissions. In the baseline assessment, DTR Medical have captured emissions for Scope 1, Scope 2, Category 1 – Purchased goods and services, Category 2 – Capital goods, Category 3 – Fuel- and energy related activities (not included in Scope 1 or Scope 2), Category 4 - Upstream transportation and distribution, Category 5 - Waste generated in operations, Category 6- Business travel (not included in Scope 1 or Scope 2), and Category 7 – Employee commuting

Emissions Reduction Targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We commit to reducing Scope 1 and Scope 2 emissions by at least 5% per year, on average, from our baseline year through to 2030, supported by energy efficiency, fuel-switching measures and continued use of Zero Carbon Electricity. Scope 3 emissions remain an area of active development; however, recent strategic changes, including two further medical company acquisitions by our parent company, Innovia Medical, and DTR Medical's appointment as distributor for UK and European customers have materially altered our value chain and created significant uncertainty around future Scope 3 boundaries and volumes. Accordingly, while we remain committed to measuring and engaging on Scope 3 in line with best practice, we are not setting a fixed absolute Scope 3 reduction target at this time and will instead focus on improving data quality and supplier engagement before defining quantitative Scope 3 targets in future iterations of this Carbon Reduction Plan.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following measures and initiatives are in-progress, planned, or under consideration, to support the achievement of our Net Zero target:

- Site wide energy efficiency measures, including full LED lighting retrofit across the factory, offices and manufacturing areas, have been implemented to reduce Scope 1 (direct) and Scope 2 (purchased electricity, heat and cooling)
- Removal of bubble wrap and introduce biodegradable air pillows and shredded cardboard as void fill materials decreasing reliance on fossil based plastic whilst supporting more recyclable and compostable packaging streams.
- Procurement of 100% renewable electricity from British Gas for Business, fully backed by REGO's and Carbon Trust assured, enabling reporting of 0g CO₂/kWh for purchased electricity under the GHG protocol eliminating Scope 2 emissions from electricity consumption.
- Supplier collaboration activities to identify opportunities to reduce Scope 3 Category 4 emissions, particularly those created by sea or air transportation.

- Introduction of electric logistics vehicles via our distribution partner, DPD, for collection of finished goods from DTR Medical and onward transport to national consolidation hubs, reducing diesel use and associated Scope 3 emissions from outbound distribution.
- Identify and implement opportunities to improve data quality, helping ensure emissions reduction efforts remain focussed where there is the biggest impact.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard and uses the appropriate Government emission conversion factors for greenhouse gas company reporting .

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard .
